Petition for Submission of Warrant Articles 8, 9, 10 and 11 Changing Needham's Zoning Bylaws to the Voters At Large

We, the undersigned registered voters of the Town of Needham, hereby petition the Select Board and request that the measures passed by the votes of Town Meeting at the Special Town Meeting held October 21, 2024 and dissolved October 22, 2024 be submitted to the voters of the town at large. Specifically, measures passed under Articles 8 and 9, as well as the Motions to Reconsider and Amend Articles 8 and 9 contained in Warrant Articles 10 and 11 shall be submitted to the voters of the town. This vote will allow the complete repeal of these articles. The town shall act forthwith to comply with the requirements of MGL Ch 40A s.3A.

The Articles and Motions as passed amend the Zoning Bylaws of the Town of Needham, including by creating Multi-Family Overlay Districts that allow multi-family housing as of right and limit the town's ability to control the development and its impacts. The changes create the capacity for 3,296 multi-family units of housing, in apartment buildings as high as 4 1/2 stories, and could displace small businesses currently in Needham. The state law required only 1,784 units.
