This application may be completed by...

- A registered voter; or
- A voter's family member (spouse, roommate, parent, sibling, child, aunt, uncle, niece, nephew, grandparent, grandchild, in-law).

Use this application to request an absentee ballot for...

A registered voter who will be unable to vote at the polls on Election Day due to absence from the voter's city or town during polling hours, disability, or religious beliefs.

OR

A non-registered voter who is:

- A Massachusetts citizen and resident of Needham absent from the state;
- An active member of the armed forces or merchant marines, their spouse or dependent; or
- A person confined to a correctional facility or jail for reasons other than felony conviction.

Completing the Application

1. **Voter Information** – Provide the voter's name, legal voting address, and date of birth. Telephone number and e-mail address are optional fields, but helpful if we have questions.
2. **Ballot Information** – Provide the address where you want the ballot mailed and indicate for which election(s) you are requesting a ballot. Applications for "all elections this year" are valid for one calendar year.
3. **Special Circumstances** – Check any of the listed circumstances which apply to this application, if any.
4. **Sign your name** – If you require assistance in signing the application, you may authorize someone to sign your name in your presence. That person must complete the assisting person's information in Section 3.

Submitting the Application

Send the completed application to the Town Clerk's Office at **1471 Highland Ave, Needham MA 02492**. Applications can be mailed, hand-delivered to the Town Clerk's Office, or dropped in the Town Clerk's Red Dropbox at the corner of Highland Ave and Garrity's Way. Applications may also be submitted electronically by e-mail, as long as the requester's signature is visible.

Please allow ample mailing time for this application and for the ballot. Ballots must be returned to Town Clerk's Office by Election Day.
